Action Items

- The board voted to approve the June 23rd board meeting minutes (Sara Batterton and Henry Hipps abstained given absence from 6/23 meeting)
- The board voted in executive session to approve the school compensating The St. James for the spring enrichment/sports programming they provided, and approved the school partnering with The St. James again this upcoming school year (Mashea Ashton and Sara Batterton were recused due to conflicts of interest).

Discussion

Mashea Ashton introduced Elizabeth Pillion, who is the school's new EdOps finance support, and Katie Thaeder, who is taking notes for today, and supporting DPA finance and operations. Ms. Ashton shared overview of the meeting: review and approval of the previous board meeting minutes, CEO update and then upcoming board dates before moving to executive session.

Mary Wells motioned to approve June 23rd board meeting minutes. Kevjorik Jones seconded and the minutes were approved. Sara Batterton and Henry Hipps abstained from voting because they were not present at the meeting.

Ms. Ashton shared in her update that the school is working hard on student enrollment. Right now the school has 528 students fully enrolled and is hoping to grow that number slightly ahead of the school year start. Ms. Ashton, when asked by Mr. Jones, explained what distinguished a scholar who is mostly enrolled versus fully enrolled. Ms. Ashton and the board also discussed the No Shots, No School Mandate in DC. At this time, DPA is not experiencing students unenrolling from school given the mandate.

Discussion (cont'd)

Ms. Ashton shared an update on hiring and that DPA has close to 28 new hires to start the year. New team members are a mix of brand new teachers and teachers bringing 4-8 years of experience who really identify with the school's mission. Ms. Ashton shared that DPA is working with two search firms to hire a Head of the Upper School and a Managing Director of Operations. She also shared that the school operations team is stretched very thin, and they are identifying ways for school leaders to support as they hire for that team.

Ms. Ashton and Ms. Pillion then discussed with the board the school's end of school year cash position of 19 days, which is below our target of 45 days. They shared that the school was closely managing the cash position throughout and that the cash position was due to a delay in federal grant reimbursements, private grant disbursements, and several large purchases made in advance of the upcoming school year. Ms. Pillion then shared ways that the school has adjusted processes to mitigate the potential for this situation in the future, and Kevjorik Jones suggested the school consider a line of credit.

Ms. Ashton concluded this portion of the board meeting by sharing upcoming board meeting dates. The next meeting will be in person on 10/6.

Executive Session

Once in Executive Session, Ms. Wells and Ms. Blanchard briefed the board on Ms. Ashton's performance review that was conducted this spring. Going forward, her review will take place annually. Ms. Wells noted that in the future they will use more data in the review, but data was more challenging given the pandemic. Overall, Ms. Ashton was lauded for her strong leadership and vision, and her perseverance over the last four years. Looking ahead, the board would like Ms. Ashton to continue focusing on student impact, organizational culture and institutional sustainability.

Ms. Ashton and Ms. Batterton then recused themselves from the call while the board discussed and voted on the school's request for approval to pay The St. James for programming provided last spring, and for the school to partner with The St. James again this upcoming year. Approval is needed due to conflicts of interest for Mashea Ashton and Sara Batterton. Ms. Wells motioned to approve, the motion was seconded, and all voted in favor of approving.

The meeting then adjourned.




DPA Budget Update


- In spring 2022, the board approved a budget for the 22-23 school year that assumed an enrollment of 600 students across 6th to 10th grade.
- In July, projecting enrollment to be lower than expected, DPA worked with EdOps to craft a 500 student contingency budget, which we are sharing to date.
 - This contingency budget largely differs from original budget in that it assumes a lower amount of staff overall.
- As of October 4th, DPA has 517 students fully enrolled at Stage 5 enrollment
